

## NOTICE

Subject: Appointment on Compassionate Ground - reg..

On the above subject, it is to inform that at this Centre upto 31.12.2021 two numbers of applications from the dependents of deceased/retired on medical ground officials were received for considering for appointment on Compassionate Ground.

The objective of the Scheme for Compassionate Appointment is to grant appointment on compassionate grounds to a dependent family member of a Government servant dying in harness or who is retired on medical grounds, thereby leaving his family in penury and without any means of livelihood. It is to relieve the family of the Government servant concerned from financial destitution and to help it get over the emergency. Keeping, in view the objective of the Scheme, the existing Appointment compassionate reviewed/modified/simplified so that the system finally derived at shall be more transparent, efficient and uniform in nature. The efficacy of the Scheme is based on its transparency. It is this aspect, which is foremost and hence while considering a request for appointment on Compassionate grounds by a Committee, a balanced and objective assessment of the financial condition of the family has to be made taking into consideration its assets and liabilities and all other relevant factors such as the presence of earning member, size of the family, ages of the children and the essential needs of the family etc. This is done to assess the degree of indigence among all the applicants considered for compassionate appointment within the prescribed ceiling of 5% of the direct recruitment vacancies. Therefore, to achieve the objective of the scheme of the Compassionate Appointment and to ensure complete transparency it was decided to assess the merits of the cases by allocating points to the applicants based on various following attributes (indicated in the references of DOP&T from time to time):

IN ADDITION TO THE ABOVE, CASES WHERE THE WIFE OF THE DECEASED OFFICIAL HAS APPLIED FOR COMPASSIONATE APPOINTMENT FOR HERSELF; BE ALLOCETED 15 ADDITIONAL POINTS AS GRACE POINTS. THIS WILL BE IN LINE WITH THE GENERAL PRINCIPLE THAT THE WIDOW NEEDS TO BE GIVEN PREFERENCE FOR COMPASSIONATE APPOINTMENT.

The above system of weightage has not only awarded objectivity to the entire method but also has ensured complete transparency and uniformity in the selection process for appointment on compassionate ground.

Accordingly, the committee constituted to consider the cases of compassionate appointment considered the applications of all the 02 applicants (detail mentioned in the table given below) and assessed the merits of their cases by allocating points to them on above mentioned various attributes and find that the applicants have obtained following points:-

As Smt. Sunita Devi, W/o Late Surendra Rai, Ex-T-1, NRCL obtained highest points, the committee constituted for considering the cases of compassionate appointment recommended her name for appointment against available one vacancy under compassionate appointment quota. Accordingly, after completion of all the formalities offer of appointment tothe post of skilled supporting staff has been issued to Smt. Sunita Devi, w/o Late Surendra Rai, Ex-T-1, NRCL.

The rest candidate(s) could not be offered compassionate appointment due to his / their relative low merit points and non-availability of vacancies. However, the case of willing candidates will again be considered as and when any vacancy is find available under compassionate appointment quota.
